"CATCH ME IF YOU CAN": TRACING ASSETS 21 YEARS AFTER *GREAT-WEST LIFE v. KNUDSON* (2002)

ERISA requires parties to seek "equitable remedies" when trying to recover for medical payments through reimbursement rights. When the injured person's attorney disburses the settlement money, your claim takes on a new task of "tracing" those funds from the settlement into new items or accounts. The presentation will step through the process to trace settlement funds that have been disbursed. Can you really get the member's house or car? What other alternatives are available?

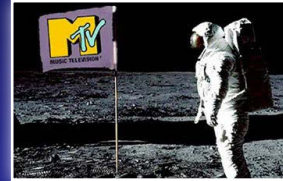

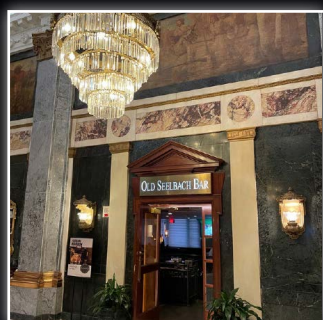
